### RESOLUTION NO. 723-2023

#### **DECLARING THE SUPPLEMENTAL BUDGET NO. 2 FOR CALENDAR YEAR 2023 OF SAN NICOLAS, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P2,854,984.81, OPERATIVE IN ITS ENTIRETY**

**WHEREAS**, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

**WHEREAS**, the Sangguniang Bayan of San Nicolas, Pangasinan submitted its Supplemental Budget No. 2 for Calendar Year 2023 involving total appropriations of P2,854,984.81, which was enacted on May 15, 2023 through Appropriation Ordinance No. 1, Series of 2023;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That the reversion of savings shall be in accordance with the provisions of Section 336 of R. A. No. 7160 (Use of Appropriated Funds & Savings);
2. That the appropriation for the implementation of the Fourth Tranche Compensation Adjustment shall be subject to the provisions of Local Budget Circular No. 149 of the Department of Budget & Management dated January 10, 2023. The appropriation for salaries of the following should therefore be adjusted as follows:
