**RESOLUTION NO. 729-2023**

**DECLARING MUNICIPAL ORDINANCE NO. 144, S-2023 OF THE SANGGUNANG BAYAN OF SAN NICOLAS, PANGASINAN, ENTITLED “AN ORDINANCE CREATING THE MEDICAL OFFICER III UNDER THE MUNICIPAL HEALTH OFFICE, DISABILITY AFFAIRS OFFICER III UNDER THE PERSONS WITH DISABILITY AFFAIRS OFFICE, AND SOCIAL WELFARE OFFICER I UNDER THE MUNICIPAL SOCIAL WELFARE AND DEVELOPMENT OFFICE IN THE LOCAL GOVERNMENT UNIT OF SAN NICOLAS, PANGASINAN AND SPECIFYING ITS QUALIFICATION AND FUNCTIONS AND PROVIDING APPROPRIATION THEREOF” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**


