## **RESOLUTION NO. 730-2023**

DECLARING MUNICIPAL ORDINANCE NO. 145, S-2023 OF THE SANGGUNIANG BAYAN OF SAN NICOLAS, PANGASINAN, ENTITLED "AN ORDINANCE DECLARING THE SECOND WEEK OF AUGUST EVERY YEAR AS "LINGGO NG KABATAAN" IN THE MUNICIPALITY OF SAN NICOLAS, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of San Nicolas, Pangasinan submitted its Ordinance No. 145, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 2 (a) (b) (c) (d) and 13 of R.A. No. 8400 or "An Act Creating the National Youth Commission, Establishing a National Comprehensive and Coordinated Program on Youth Development, Appropriating Funds Therefore, and for Other Purposes" and the 1987 Philippine Constitution";

WHEREFORE, in view of the foregoing, on motion of SP Members Noel C. Bince and Salvador S. Perez, Jr. and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was–

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 145, S-2023 of the Sangguniang Bayan of San Nicolas, Pangasinan, entitled "An Ordinance declaring the second week of August every year as "Linggo ng Kabataan" in the Municipality of San Nicolas, Pangasinan" as within the conferred powers of the Sangguniang Bayan to enact;
