PROVINCIAL RESOLUTION NO. 734-2023

AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A DEED OF DONATION FOR THE AWARDING OF A BRAND NEW PRELIMINARY DISINFECTION AND STORAGE FACILITY FROM THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES-ENVIRONMENTAL MANAGEMENT BUREAU (DENR-EMB) REGION I

WHEREAS, the Department of Environment and Natural Resources-Environmental Management Bureau (DENR-EMB) is the principal agency of the government which implements and regulates hazardous waste management in the country in coordination with other partners and stakeholders;

WHEREAS, the Province of Pangasinan will be the recipient of a Brand New Preliminary Disinfection and Storage Facility from the Department of Environment and Natural Resources-Environmental Management Bureau (DENR-EMB) Region I;

WHEREAS, the said storage facility can be used primarily and effectively by the Province through the provincial government hospitals in order to address Covid-19 related waste from quarantine, testing and vaccination facilities in Pangasinan;

WHEREAS, it is to the best interest of the Provincial Government of Pangasinan to sign the Deed of Donation for the awarding of the said storage facility from DENR-EMB to further improve the collection of Covid-19 related healthcare waste in the Province;

WHEREAS, for the above purpose, the Deed of Donation shall be entered into and signed between the Province of Pangasinan, represented by Governor Ramon V. Guico III, and the DENR-EMB, represented by Engr. Maria Dorica Naz-Hipe, Regional Director;


