APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 5 OF THE PROVINCE OF PANGASINAN FOR CALENDAR YEAR 2023

WHEREAS, presented for consideration is the Supplemental Investment Program No. 5 of the Province of Pangasinan for Calendar Year 2023 as endorsed by the Provincial Development Council through PDC Execom Resolution No. 05-23;

WHEREAS, Supplemental Investment Program No. 5 contains programs, projects and activities that were not included in the approved 2023 Annual and Supplemental Investment Programs of the Province of Pangasinan;

WHEREAS, the Supplemental Investment Program covers fund augmentation for the Personal Services of provincial offices and hospitals as well as implementation of other priority programs and projects of the province under Other Special Purpose Appropriations;

WHEREAS, the said Supplemental Investment Program likewise covers the granting of FY 2022 Performance Based Bonus (PBB) to provincial officials and employees of the province in accordance with Joint Memorandum Circular No. 2023-001 of the DILG and DBM, being a passer and awardee of the Seal of Good Local Governance for CY 2022;

WHEREAS, also included in Supplemental Investment Program No. 5 is the implementation of various infrastructure projects proposed to be funded from current and continuing appropriations;

WHEREAS, the programs, projects and activities identified to be funded from the said sources are geared toward the socio-economic development goals and thrusts of the Province;
