PROVINCIAL RESOLUTION NO. 742-2023

AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A CONTRACT OF WATER SERVICE WITH ALL COMMERCIAL STALLS WITHIN THE PROVINCIAL CAPITOL COMPOUND FOR THE PROVISION OF WATER SERVICE AND IMPOSITION OF CHARGES AND FEES THEREOF

WHEREAS, the Provincial Government of Pangasinan is the absolute and exclusive owner of the provincial buildings and commercial stalls within the Provincial Capitol Compound;

WHEREAS, the commercial stalls operating within the Provincial Capitol Compound are lessees of the Provincial Government to cater to the needs of the provincial officials and employees including clients of the Province;

WHEREAS, the lessees of the commercial stalls have expressed their intention/request for water service connection in furtherance of their businesses of preparing and serving foods and drinks/refreshments, to cater to customers in the area;

WHEREAS, the lessees shall undertake to pay the installation fee and monthly water bill based on the computation provided for under Section 56 on Provincial Waterworks System Charge of Provincial Tax Ordinance No. 1-2022 of the Province of Pangasinan;

WHEREAS, this Sanggunian finds that a Contract of Water Service is necessary pertaining to the use of water supplied by the Provincial Waterworks System to commercial stalls within the Provincial Capitol Compound;

WHEREAS, Section 22 (a) (5) of the Local Government Code of 1991 states that "Every local government unit, as a corporation, shall have corporate power to enter into contracts";

WHEREAS, Section 22 (c) of the same Code further stipulated that "Unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the Sanggunian concerned";

WHEREAS, for the above purpose, a Contract of Water Service shall be entered into and signed between the Province of Pangasinan, represented by Governor Ramon V. Guico III, and the lessees;

NOW, THEREFORE, on motion of SP Member Apolonia DG. Bacay, duly seconded, it was -

RESOLVED, by the Sangguniang Panlalawigan in session assembled to authorize, as he is hereby authorized, the Provincial Governor, Ramon V. Guico III, to enter into and sign a Contract of Water Service with all commercial stalls within the Provincial Capitol Compound for the provision of water service and imposition of charges and fees thereof;

RESOLVED, FINALLY, that copies of this resolution be furnished to the Provincial Governor, Ramon V. Guico III, Province of Pangasinan, and the lessees of commercial stalls, for their information and guidance.
