DECLARING ORDINANCE NO. 2023-23 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED "AN ORDINANCE TEMPORARILY SUSPENDING THE IMPOSITION OF PENALTY ON WEARING OF SLIPPERS AND SHORTS BY TRICYCLE DRIVERS IN THE CITY DULY PROVIDED UNDER ARTICLE XXV (1) OF CITY ORDINANCE NO. 2021-13, OTHERWISE KNOWN AS "THE 2021 AMENDMENT TO THE TRAFFIC CODE" OF THE CITY OF ALAMINOS, PANGASINAN FROM 28 JUNE 2023 TO 31 OCTOBER 2023" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG PANLUNGSOD TO ENACT
