RESOLUTION NO. 747-2023

DECLARING ORDINANCE NO. 211, S-2023 OF THE SANGGUNANG BAYAN OF BASISTA, PANGASINAN, ENTITLED "AN ORDINANCE AMENDING SECTIONS 3, 4, 5, 6 & 7 OF THE MUNICIPAL ORDINANCE NO. 109, SERIES OF 2019, ENTITLED "AN ORDINANCE REGULATING THE SALE, DISTRIBUTION, POSSESSION AND USE OF FIRECRACKERS AND PYROTECHNIC DEVICES AND SUCH OTHER SIMILAR DEVICES WITHIN THE TERRITORIAL JURISDICTION OF BASISTA, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Basista, Pangasinan submitted its Ordinance No. 211, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 16 & 447 (a) (1) (ii) (iii) of R. A. No. 7160 and Sections 1 & 4 of the Republic Act No. 7183, otherwise known as "An Act Regulating the Sale, Manufacture, Distribution, and Use of Firecrackers and Other Pyrotechnic Devices";

WHEREAS, the subject ordinance shall take effect after compliance with the requirements of posting and publication pursuant to Sections 59 (c) and 511 (a) of R. A. No. 7160;


