**PROVINCIAL RESOLUTION NO. 75-2023**

**AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A MEMORANDUM OF UNDERSTANDING BETWEEN AND AMONG THE PHILIPPINE DRUG ENFORCEMENT AGENCY -REGION I, PNP-PANGASINAN POLICE PROVINCIAL OFFICE, BURGOS POLICE STATION, BUREAU OF FIRE PROTECTION-BURGOS, DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT, DEPARTMENT OF EDUCATION, TECHNICAL EDUCATION SKILLS DEVELOPMENT AUTHORITY-PROVINCIAL TRAINING CENTER, RELIGIOUS SECTOR, RURAL HEALTH UNIT OF BURGOS AND THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT FOR THE IMPLEMENTATION OF "BALAY SILANGAN" REFORMATION PROGRAM (BSRP) IN THE PROVINCE OF PANGASINAN**

**WHEREAS**, Board Resolution No. 3, S-2022 of the Dangerous Drugs Board provides for the enhancement of the "Balay Silangan" Reformation Program (BSRP) and sets forth the guidelines for the implementation of the program particularly on the coordination among LGUs with the national government and other stakeholders in providing interventions (livelihood and training programs) to drug personalities who surrendered voluntarily;

**WHEREAS**, it is the purpose of the Provincial Government of Pangasinan to implement the BSRP in the Province by providing the infrastructure facility dedicated as "Balay Silangan" through the Pangasinan Reformation Center located in Burgos, Pangasinan;

**WHEREAS**, the "Balay Silangan" can be used primarily by the Province as a venue for reformation center in order to cater and respond to the needs of those who are to undergo reformatory program in order to change their old ways of being drug offenders and go back to the normal society;

**WHEREAS**, the Provincial Government aims to collaborate with local government units, concerned national line agencies, and other stakeholders in undertaking the program through the reformation of People Who Use Drugs (PWUDs) by providing them with livelihood training and after-care for their early recovery and reintegration into the community;

**WHEREAS**, it is to the best interest of the Provincial Government of Pangasinan to enter into and sign a Memorandum of Understanding with the concerned parties in order to pursue this noble aim of accrediting the Pangasinan Reformation Center as “Balay Silangan” Reformation Center to finally realize the dream of the Province of providing a fully operational facility for PWUDs;

**NOW, THEREFORE**, in view of the foregoing, on motion of SP Member Jerry Agerico B. Rosario, duly seconded, it was –


