RESOLUTION NO. 750-2023

DECLARING ORDINANCE NO. 218, S-2023 OF THE SANGGUNIANG BAYAN OF BASISTA, PANGASINAN, ENTITLED “AN ORDINANCE ASSIGNING ONE (1) DAY FOR THE “ORCHESTRA FESTIVAL” DURING THE ANNUAL TOWN FIESTA CELEBRATION OF THE MUNICIPALITY OF BASISTA, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Basista, Pangasinan submitted its Ordinance No. 218, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 16 & 447 (a) (1) (6) of R. A. No. 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Philip Theodore E. Cruz and Haidee S. Pacheco and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 218, S-2023 of the Sangguniang Bayan of Basista, Pangasinan, entitled “An Ordinance assigning one (1) day for the ‘Orchestra Festival’ during the Annual Town Fiesta celebration of the Municipality of Basista, Pangasinan” as within the conferred powers of the Sangguniang Bayan to enact;
