RESOLUTION NO. 751-2023

DECLARING MUNICIPAL ORDINANCE NO. 08, S-2023 OF THE SANGGUNANG BAYAN OF BINMALEY, PANGASINAN, ENTITLED “AN ORDINANCE SETTING GUIDELINES FOR HONORING DECEASED BARANGAY OFFICIALS INCLUDING BARANGAY TANODS AND BARANGAY HEALTH WORKERS AND OTHER CIVILIANS OF BINMALEY, PANGASINAN, WHO HAD RENDERED DISTINGUISHED SERVICE BY DRAPING OVER THE CASKET WITH THE FLAG OF THE REPUBLIC OF THE PHILIPPINES” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Binmaley, Pangasinan submitted its Municipal Ordinance No. 08, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Section 16 of R. A. No. 7160, and Republic Act No. 8491, otherwise known as the “Flag and Heraldic Code of the Philippines”;

WHEREAS, the Sangguniang Bayan shall comply to the written opinion of the Provincial Legal Officer dated July 16, 2023;
