RESOLUTION NO. 752-2023

DECLARING MUNICIPAL ORDINANCE NO. 6-2023 OF THE SANGGUNIANG BAYAN OF URBIZTONDO, PANGASINAN, ENTITLED "AN ORDINANCE REGULATING THE MANUFACTURE, DISTRIBUTION, SALE, PURCHASE, AND USE OF FIRECRACKERS, PYROTECHNIC DEVICES, AND OTHER EXPLOSIVES OF SIMILAR NATURE WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF URBIZTONDO, PANGASINAN, PROVIDING PENALTIES IN VIOLATION THEREOF, AND REPEALING LOCAL ORDINANCE NO. 9, SERIES OF 1991" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Urbiztondo, Pangasinan submitted its Municipal Ordinance No. 6-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 16 & 447 (a) (1) (ii) (iii) of R. A. No. 7160 and Sections 1 and 4 of the Republic Act No. 7183, otherwise known as the "An Act Regulating the Sale, Manufacture, Distribution and Use of Firecrackers and other Pyrotechnic Devices";

WHEREAS, the subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 511 (a) of R. A. No. 7160;


