APPROVING RESOLUTION NO. 2023-076 OF THE SANGGUNIANG BAYAN OF TAYUG, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL AIP PURSUANT TO APPROPRIATION ORDINANCE NO. 2023-001 OF THE MUNICIPALITY OF TAYUG, PANGASINAN INVOLVING AN AMOUNT OF FORTY-ONE MILLION SIXTY-EIGHT THOUSAND THIRTY-EIGHT PESOS AND 39/100 (P41,068,038.39)"

WHEREAS, the Sangguniang Bayan of Tayug, Pangasinan submitted its Resolution No. 2023-076 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

- Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Tayug, Pangasinan has identified items in their Supplemental Annual Investment Program. This was endorsed to the Sangguniang Bayan on July 10, 2023 through MDC Resolution No. 2023-01;
- The SIP of the municipality covers fund augmentation for the Maintenance and Other Operating Expenses and Capital Outlay of some municipal offices and the implementation of disaster risk reduction programs of LGU Tayug; and

> 3. Funding support for the proposed SAIP, with a total investment requirement of Php41,068,038.39 is embodied in the municipality's Supplemental Budget No. 1, which was approved and enacted by their Sangguniang Bayan through Appropriation Ordinance No. 2023-001 on July 12, 2023.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Tayug, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Noel C. Bince and Salvador S. Perez, Jr. and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was-
