RESOLUTION NO. 756-2023

DECLARING MUNICIPAL ORDINANCE NO. 2023-011 OF THE SANGGUNIANG BAYAN OF TAYUG, PANGASINAN, ENTITLED “AN ORDINANCE PROHIBITING GENDER-BASED SEXUAL HARASSMENT IN THE STREETS AND PUBLIC SPACES IN THE MUNICIPALITY OF TAYUG, PANGASINAN, OTHERWISE KNOWN AS “BAWAL-BASTOS LAW”, PROVIDING THE GUIDELINES IN THE IMPLEMENTATION THEREOF AND PRESCRIBING PENALTIES FOR VIOLATIONS THEREOF” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Tayug, Pangasinan submitted its Municipal Ordinance No. 2023-011 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Section 17 (a) (iv) of R.A. No. 7160; Republic Act No. 11313 or “Safe Spaces Act”; Republic Act No. 7877 or “Anti-Sexual Harassment Act of 1995”; Republic Act No. 9208 “Anti-Trafficking in Persons Act of 2003”; Republic Act No. 9262 or “Anti-Violence Against Women and Their Children Act of 2004”; Republic Act No. 9995 or “Anti-Photo and Video Voyeurism Act of 2009”; Republic Act No. 9775 or “Anti-Child Pornography Act of 2009”; and Republic Act No. 7610 or “Special Protection of Children Against Abuse, Exploitation and Discrimination Act”;

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance 2023-011 of the Sangguniang Bayan of Tayug, Pangasinan, entitled “An Ordinance prohibiting gender-based sexual harassment in the streets and public spaces in the Municipality of Tayug, Pangasinan, otherwise known as ‘Bawal-Bastos Law’, providing the guidelines in the implementation thereof and prescribing penalties for violations thereof” as within the conferred powers of the Sangguniang Bayan to enact;
