PROVINCIAL RESOLUTION NO. 764-2023

INTERPOSING NO OBJECTION TO AND ENDORSING THE INSTALLATION, OPERATION AND MAINTENANCE OF THE LAOAG-AGUILAR SOLAR POWER PROJECT OF PV SINAG POWER, INC. LOCATED IN BARANGAY LAOAG, AGUILAR, PANGASINAN

WHEREAS, PV Sinag Power, Inc., a subsidiary company of Aboitiz Power Corporation and a renewable energy developer and solar power producer, has applied for and proposed to develop and operate a 128MWac and 254GWh generation capacity of Laoag-Aguilar Solar Power Project at its identified project site located at Barangay Laoag, Aguilar, Pangasinan;

WHEREAS, PV Sinag Power, Inc. has presented to the Sangguniang Panlalawigan the purpose of the project during its Regular Session held on June 19, 2023 and provided information in order to accelerate the energy program in the area apart from the socioeconomic and environmental benefits that Pangasinan as host province will enjoy;

WHEREAS, as manifested during the said presentation, PV Sinag Power, Inc. was able to secure the Special Land Use Permit for Laoag 1 in 2019, Special Land Use Permit for Laoag 2 in 2020, including Environmental Compliance Certificate and tree cutting permits in 2021;

WHEREAS, PV Sinag Power, Inc. is cognizant to its Social Responsibility and is committed to comply with Section 13 of the Renewable Energy Act of 2008 or RA 9513 and Rule 7, Section 20 of the IRR of RA 9153 as well as ER 1-94 which specifies the financial benefits that should be availed by the host communities from the RE developers/producers by setting aside one centavo per kilowatt hour (0.01/kwh) of the total electricity sales;

WHEREAS, the establishment of an alternative source of power is a welcome development in the Province of Pangasinan considering the present high cost of energy in the country;

WHEREAS, subject to compliance with pertinent laws, existing rules, regulations and ordinances appurtenant to the implementation of the Laoag-Aguilar Solar Power Project, the Sangguniang Panlalawigan interposes no objection to the request and consequently endorses the same;

NOW, THEREFORE, on motion of SP Member Noel C. Bince, duly seconded, it was –

RESOLVED, by the Sangguniang Panlalawigan in session assembled to interpose, as it is hereby interposed, no objection to and endorsing the installation, operation and maintenance of the Laoag-Aguilar Solar Power Project of PV Sinag Power, Inc. located in Barangay Laoag, Aguilar, Pangasinan;
