PROVINCIAL RESOLUTION NO. 765-2023

AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH THE MUNICIPALITY OF BINALONAN, PANGASINAN, REPRESENTED BY MAYOR RAMON RONALD V. GUICO IV, FOR THE DESIGNATION/TEMPORARY ASSIGNMENT OF ATTY. MARLON C. OPERAÑA, PROVINCIAL ACCOUNTANT, AS IN-CHARGE OF THE OFFICE OF THE MUNICIPAL ACCOUNTANT OF BINALONAN, PANGASINAN

WHEREAS, in his letter dated August 22, 2023, Municipal Mayor Ramon Ronald V. Guico IV of Binalonan, Pangasinan, has requested the Province of Pangasinan, through the Provincial Governor, Ramon V. Guico III, to enter into a Memorandum of Agreement (MOA) for the designation of an accountant in the Municipality of Binalonan, Pangasinan;

WHEREAS, the above request was brought about by the retirement of the Municipal Accountant of Binalonan, Pangasinan effective September 1, 2023, in order to ensure the continuity of financial transaction in the said municipality;

WHEREAS, based on the letter of Municipal Mayor Guico IV, the Civil Service Commission has stated in its opinion that a provincial or municipal government may enter into a Memorandum of Agreement designating an accountant in Binalonan, Pangasinan on a temporary basis to ensure the continuity of operation of the concerned office;

WHEREAS, the Provincial Legal Office has also opined that the requested MOA and the designation of an accountant in the municipality is in accordance with Section 12 (3) (14), Chapter 3, Title I (A), Book V of the Administrative Code of 1987; and Section 13 (b) 2017 Omnibus Rules on Appointments and other Human Resource Actions (Revised July 2018);

WHEREAS, the Provincial Governor, Ramon V. Guico III, interposes no objection to the said request;

WHEREAS, Section 22 (c) of RA 7160 stipulated that “Unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the Sanggunian concerned”;

WHEREAS, Section 465 (vi) of RA 7160 further provides that the Provincial Governor shall represent the Province in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon authority of the Sangguniang Panlalawigan or pursuant to law or ordinance;


WHEREAS, for the above purpose, a Memorandum of Agreement shall be entered into and signed between the Province of Pangasinan, represented by the Provincial Governor, Ramon V. Guico III and the Municipality of Binalonan, represented by the Municipal Mayor, Ramon Ronald V. Guico IV;

NOW THEREFORE, on motion of SP Member Nicholi Jan Louie Q. Sison, duly seconded, it was -


RESOLVED, by the Sangguniang Panlalawigan in session assembled to authorize, as he is hereby authorized, the Provincial Governor, Ramon V. Guico III, to enter into and sign a Memorandum of Agreement with the Municipality of Binalonan, Pangasinan, represented by Mayor Ramon Ronald V. Guico IV, for the designation/temporary assignment of Atty. Marlon C. Operaña, Provincial Accountant, as In-Charge of the Office of the Municipal Accountant of Binalonan, Pangasinan;
