APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 6 OF THE PROVINCE OF PANGASINAN FOR CALENDAR YEAR 2023

WHEREAS, presented for consideration is the Supplemental Investment Program No. 6 of the Province of Pangasinan for Calendar Year 2023 as endorsed by the Provincial Development Council through PDC Execom Resolution No. 07-23;

WHEREAS, Supplemental Investment Program No. 6 contains programs, projects and activities that were not included in the approved 2023 Annual and Supplemental Investment Programs of the Province of Pangasinan;

WHEREAS, the Supplemental Investment Program covers the purchase of lot intended for future development projects to be funded from the reprogrammed Land Banking project under Supplemental Investment Program No. 2;

WHEREAS, said Land Banking initiative shall now cover the lots to be purchased in the municipalities of Manaoag, San Fabian, and Infanta, all in the Province of Pangasinan;
