PROVINCIAL RESOLUTION NO. 768-2023

AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH THE BUREAU OF FIRE PROTECTION-REGION I FOR THE MAINTENANCE OF ONE (1) FIRE TRUCK (ISUZU ANOS NQR FIRE TRUCK WITH PLATE NO. SHY 825)

WHEREAS, the Sangguniang Panlalawigan is in receipt of a request-letter from the Provincial Administrator, Mr. Melicio F. Patague II, dated September 5, 2023 relative to a Memorandum of Agreement (MOA) to be entered into by and between the Province of Pangasinan and the Bureau of Fire Protection for the provision/maintenance of the Isuzu Anos NQR Fire Truck with Plate No. SHY 825;

WHEREAS, the said request was brought about by the letter of SINSP Kevin G. Banawag, Municipal Fire Marshal of the Bureau of Fire Protection, Pangasinan Provincial Office-Region I, dated June 30, 2023, 2023, addressed to the Provincial Governor, Ramon V. Guico III, for the renewal of the said Memorandum of Agreement (MOA) between the two parties;

WHEREAS, accordingly, the fire truck is being manned by the designated Capitol Fire Brigade members stationed at the Lingayen Fire Station;

WHEREAS, fire trucks are very important and essential firefighting equipment to be maintained and utilized by a local government unit during times of emergencies and calamities, whether man-made or natural disasters;

WHEREAS, the Provincial Legal Office has opined that the requested MOA and its subject matter is in accordance with Sections 2, 54 and 56 of RA 6975 or the Department of the Interior and Local Government Act of 1990;

WHEREAS, Section 22 (a) (5) (c) of RA 7160 stipulated that “Unless otherwise provided in the Local Government Code of 1991, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the Sanggunian concerned”;

WHEREAS, Section 465 (vi) of the said Code further provides that the Provincial Governor shall represent the Province in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon authority of the Sangguniang Panlalawigan or pursuant to law or ordinance;

WHEREAS, for the above purpose, a Memorandum of Agreement shall be entered into and signed between the Province of Pangasinan, represented by the Provincial Governor, Ramon V. Guico III and the Bureau of Fire Protection-Region I, represented by the Regional Director, FCSupt Leonida V. Gumanab-Rosales;

NOW THEREFORE, on motion of SP Members Jeanne Jinky C. Zaplan and Haidee S. Pacheco, duly seconded, it was -

RESOLVED, by the Sangguniang Panlalawigan in session assembled to authorize, as he is hereby authorized, the Provincial Governor, Ramon V. Guico III, to enter into and sign a Memorandum of Agreement with the Bureau of Fire Protection-Region I for the maintenance of one (1) Fire Truck (Isuzu Anos NQR Fire Truck with Plate No. SHY 825);

RESOLVED FINALLY, to furnish copies of this resolution to the Provincial Governor, Ramon V. Guico III, Province of Pangasinan, and FCSupt Leonida V. Gumanab-Rosales, Regional Director, Bureau of Fire Protection-Region 1, for their information and guidance.
