RESOLUTION NO. 775-2023

DECLARING MUNICIPAL ORDINANCE NO. 02, S-2023 OF THE SANGGUNIANG BAYAN OF DASOL, PANGASINAN, ENTITLED "AN ORDINANCE CREATING THE FOLLOWING POSITIONS: LOCAL TREASURY OPERATIONS OFFICER III – SG-18; NURSE IV – SG-18; DENTIST II – SG-16; AND DAY CARE WORKER II – SG-8 IN THE MUNICIPALITY OF DASOL, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Dasol, Pangasinan submitted its Ordinance No. 02, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;


