**APPROVING RESOLUTION NO. 2022-229 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTILED "CONFIRMING/APPROVING IN TOTO THE PROPOSED CY 2022 SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 04 OF THE CITY OF ALAMINOS, PANGASINAN AMOUNTING TO NINE MILLION FIVE HUNDRED SIXTEEN THOUSAND THREE HUNDRED SEVENTY-FIVE PESOS (P9,516,375.00)"**

**WHEREAS**, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its SP Resolution No. 2022-229 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SP Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Alaminos City, Pangasinan has identified items in their Supplemental Annual Investment Program (SAIP) No. 04, Series of 2022. This was endorsed to the Sangguniang Panlungsod for approval on December 21, 2022 by the City Development Council Executive Committee thru Resolution No.02-2022 Series of 2022, and was favorably acted upon by the Sangguniang Panlungsod on December 23, 2022 thru Resolution No. 2022-229;

2. Said SIP covers fund augmentation for Personal Services (Granting of Service Recognition Incentive to LGU Officials and Employees) and Maintenance and Other Operating Expenses of some city government offices; and
3. Funding support for the implementation of the same in the amount of PhP9,516,375.00 is embodied in their proposed Supplemental Budget No. 4 for Fiscal Year 2022 which was enacted by their Sangguniang Panlungsod thru Appropriation Ordinance No. 2022-05 on December 23, 2022 and approved by the Mayor on December 28, 2022.

**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the City Government of Alaminos, Pangasinan;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to approve SP Resolution No. 2022-229 of the Sangguniang Panlungsod of Alaminos, Pangasinan, entitled “Resolution Confirming/Approving in Toto the Proposed CY 2022 Supplemental Annual Investment Program No. 04 of the City of Alaminos, Pangasinan amounting to Nine Million Five Hundred Sixteen Thousand Three Hundred Seventy-Five Pesos (P9,516,375.00)”;
