### RESOLUTION NO. 780-2023

**DECLARING MUNICIPAL ORDINANCE NO. 03-2023 OF THE SANGGUNIANG BAYAN OF MANAOAG, PANGASINAN, ENTITLED “AN ORDINANCE ABOLISHING THE PLANTILLA POSITION OF STENOGRAPHER II, ITEM NO. 74, SALARY GRADE 6, IN THE OFFICE OF THE SANGGUNIANG BAYAN OF LGU MANAOAG, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Manaoag, Pangasinan submitted its Ordinance No. 03-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 76 and 447 (a) (1) (viii) of R. A. No. 7160;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Marinor B. De Guzman and Jerry Agerico B. Rosario and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 03-2023 of the Sangguniang Bayan of Manaoag, Pangasinan, entitled “An Ordinance abolishing the plantilla position of Stenographer II, Item No. 74, Salary Grade 6, in the Office of the Sangguniang Bayan of LGU Manaoag, Pangasinan” as within the conferred powers of the Sangguniang Bayan to enact;


