RESOLUTION NO. 782-2023

APPROVING RESOLUTION NO. 2023-198 OF THE SANGGUNIANG BAYAN OF MANGALDAN, PANGASINAN, ENTITLED "APPROVING AND ADOPTING THE REVISED ANNUAL INVESTMENT PROGRAM (AIP) FOR CY 2023 INDICATING THE ADDITIONAL PROGRAMS, PROJECTS AND ACTIVITIES (PPAs) TO BE FUNDED FROM THE UNEXPENDED BALANCES OF THE MUNICIPAL DISASTER RISK REDUCTION MANAGEMENT FUND (MDRRMF) CY 2019 TO 2022 OF THE MUNICIPALITY OF MANGALDAN, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Mangaldan, Pangasinan submitted its SB Resolution No. 2023-198 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. The Municipal Development Council of Mangaldan, Pangasinan proposed for the revision of their Annual Investment Program (AIP) for CY 2023. This was endorsed by the Council, through MDC Resolution No. 4, Series of 2023 dated June 20, 2023, to the Sangguniang Bayan for approval. This is in accordance to Sections 106, 109 and 114 of the Local Government Code of 1991;

2. The LGU revised their AIP for CY 2023 to include new projects proposed to be funded from their Unexpended Balances of Municipal Disaster Risk Reduction and Management (LDRRM) Fund (CY 2019, 2020, 2021 and 2022) amounting to P7,761,793.39, which emanated from the MDRRM Council Resolution No. 2 - 2023 dated June 16, 2023.

This is in pursuance to Section 6.5 of the NDRRM Council Resolution No. 2013-1 dated March 25, 2013, to quote: "The unexpended balances of the LDRRM Fund may be released and utilized for new expenditure items upon submission of a revised AIP as approved by the Local Sanggunian and Local Chief Executive (LCE) upon recommendation of the LDRRM Council in accordance with the approved LDRRM Plan"; and

3. The proposed projects conform with NDRRM Council Resolution No. 2013-1 dated March 25, 2013 (Utilization of the LDRRM Fund/Projects and Activities).

WHEREAS, the Sanggunian Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Mangaldan, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Marinor B. De Guzman and Jerry Agerico B. Rosario and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—

RESOLVED, by the Sanggunian Panlalawigan in session assembled, to approve SB Resolution No. 2023-198 of the Sanggunian Bayan of Mangaldan, Pangasinan, entitled "Approving and adopting the Revised Annual Investment Program (AIP) for CY 2023 indicating the additional programs, projects and activities (PPAs) to be funded from the unexpended balances of the Municipal Disaster Risk Reduction Management Fund (MDRRMF) CY 2019 to 2022 of the Municipality of Mangaldan, Pangasinan";
