RESOLUTION NO. 783-2023

APPROVING RESOLUTION NO. 2023-188 OF THE SANGGUNIANG BAYAN OF MANGALDAN, PANGASINAN, ENTITLED "APPROVING AND ADOPTING THE SUPPLEMENTAL ANNUAL INVESTMENT PLAN (AIP) NO. 2, CY 2023 OF THE MUNICIPALITY OF MANGALDAN, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Mangaldan, Pangasinan submitted its SB Resolution No. 2023-188 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. The Municipal Development Council of Mangaldan, Pangasinan prepared the Supplemental Annual Investment Program (SAIP) No. 2, CY 2023 of the LGU. This was endorsed by the Council, through MDC Resolution No. 3, Series of 2023 dated June 20, 2023, to the Sangguniang Bayan for approval. This is in accordance to Sections 106, 109 and 114 of the Local Government Code of 1991;

2. Said Supplemental AIP No. 2, CY 2023, which has a total investment requirement of ₱5,000,000.00, covers fund augmentation for Maintenance and Other Operating Expenses (MOOE) office of the Sangguniang Bayan; and
3. Funding for the Supplemental AIP is embodied in the LGU's Supplemental Budget No. 2, CY 2023, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 2023-02 dated July 13, 2023.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Mangaldan, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Marinor B. De Guzman and Jerry Agerico B. Rosario and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—
