RESOLUTION NO. 785-2023

DECLARING MUNICIPAL ORDINANCE NO. 2023-002 OF THE SANGGUNIANG BAYAN OF LAOAC, PANGASINAN, ENTITLED “AN ORDINANCE PROVIDING FOR A COMPREHENSIVE YOUTH WELFARE AND DEVELOPMENT CODE IN THE MUNICIPALITY OF LAOAC, PANGASINAN, AND FOR OTHER PURPOSES” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Laoac, Pangasinan submitted its Ordinance No. 2023-002 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Local Finance Committee of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 2, 17 (a) (b) (2) (iv) and 447 (5) (xiv) of R. A. No. 7160; Republic Act No. 5462, otherwise known as the “Manpower and Out-of-School Youth Development Act of the Philippines; Republic Act No. 8044 otherwise known as the “Youth in Nation-Building Act”; Presidential Decree No. 603, S-1994 or “The Child and Youth Welfare Code”;
