RESOLUTION NO. 789-2023

APPROVING RESOLUTION NO. 2023-238 OF THE SANGGUNIANG BAYAN OF BALUNGAO, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (SAIP) NO. 4, FOR CALENDAR YEAR 2023 OF THE MUNICIPALITY OF BALUNGAO, PANGASINAN”

WHEREAS, the Sangguniang Bayan of Balungao, Pangasinan submitted its SB Resolution No. 2023-238 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Balungao, Pangasinan had identified items in their Supplemental Investment Program (SIP) No. 4 for CY 2023. This was endorsed to the Sangguniang Bayan for approval on June 14, 2023 by the Municipal Development Council through Resolution No. 2023-05;
2. The SAIP No. 4 of the municipality covers fund augmentation for Personal Services, Maintenance and Other Operating Expenses and Capital Outlay of some municipal offices of LGU Balungao; and

3. Funding support for the implementation of the same in the amount of PhP14,255,479.84 is embodied in their proposed Supplemental Budget No. 02 for Calendar Year 2023 which was enacted by their Sangguniang through Appropriation Ordinance No. 2023-02 on July 10, 2023.


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Balungao, Pangasinan;


