### RESOLUTION NO. 791-2023

**APPROVING RESOLUTION NO. 156-2023 OF THE SANGGUNIANG BAYAN OF ROSALES, PANGASINAN, ENTITLED “APPROVING SUPPLEMENTAL INVESTMENT PLAN NO. 02, CY 2023 INVOLVING AN AMOUNT OF TWENTY MILLION FOUR HUNDRED TWENTY-FIVE THOUSAND TWO HUNDRED NINETY-THREE PESOS AND EIGHTY-SIX CENTAVOS (PHP20,425,293.86) FUNDED FROM THE 20% DEVELOPMENT FUND AND SHARE FROM NATIVE TOBACCO AND BURLEY EXCISE TAX UNDER RA 8240-LBM NOS. 83, 84 AND 86 FOR PURPOSES OF FUNDING THE PROGRAMS IN THE MUNICIPALITY OF ROSALES, PANGASINAN”**

**WHEREAS**, the Sangguniang Bayan of Rosales, Pangasinan submitted its SB Resolution No. 156-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. The Local Development Council of Rosales, Pangasinan had identified items in their Supplemental Investment Program (SIP) No. 02 for CY 2023. This was endorsed to the Sangguniang Bayan for approval on July 4, 2023 by the Municipal Development Council through Resolution No. 0704 s.2023. This is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991;

2. Said Supplemental Investment Program No.02 with a total investment requirement of Php20,425,293.86 covers the implementation of development projects proposed to be funded from the realigned 20% Development Fund in the amount of Php15,721,017.86 which are in accordance with DBM-DOF-DILG Joint Memorandum Circular (JMC) No.1 dated November 4, 2020 ‘Revised Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment for Development Projects’;
3. Said SIP also covers the “Supply and delivery of fertilizers” to be funded from the municipality’s shares from Native Tobacco and Burley Excise Tax amounting to Php4,704,276.00 which is consistent with Local Budget Memorandum No. 86 dated December 14, 2022 “Guidelines on the Release and Utilization of the Shares of Local Government Units (LGUs) from the FY 2020 Collections of Excise Taxes on locally manufactured Virginia-Type Cigarettes under Republic Act (RA) No 7171, and Burley and Native Tobacco Excise Taxes pursuant to RA No. 8240, as amended by RA No.10351, and as further amended by RA 11346, chargeable against the Allocations to Local Government Units (ALGU) under the FY 2022 General Appropriations Act (GAA), RA No. 11639”; and
4. Funding support for the implementation of the same is embodied in their proposed Supplemental Budget No.02 for C.Y. 2023 which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 02-2023 on July 24, 2023.

**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Rosales, Pangasinan;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Noel C. Bince and Salvador S. Perez, Jr. and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—

**RESOLVED**, By The Sangguniang Panlalawigan In Session Assembled, To Approve SB Resolution No. 156-2023 of the Sangguniang Bayan of Rosales, Pangasinan, entitled “Approving Supplemental Investment Plan No. 02, CY 2023 involving an amount of Twenty Million Four Hundred Twenty-Five Thousand Two Hundred Ninety-Three Pesos and Eighty-Six Centavos (Php20,425,293.86) funded from the 20% Development Fund and Share from Native Tobacco and Burley Excise Tax under RA 8240-LBM Nos. 83, 84 and 86 for purposes of funding the programs in the Municipality of Rosales, Pangasinan”;
