RESOLUTION NO. 793-2023

DECLARING MUNICIPAL ORDINANCE NO. 03-2023 OF THE SANGGUNIANG BAYAN OF ROSALES, PANGASINAN, ENTITLED “AN ORDINANCE UPDATING THE COMPREHENSIVE CHILD AND YOUTH WELFARE CODE OF THE MUNICIPALITY OF ROSALES, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT

WHEREAS, the Sangguniang Bayan of Rosales, Pangasinan submitted its Ordinance No. 03-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with the United Nations Convention on the Rights of the Child (CRC); Presidential Decree No. 603 (The Child and Youth Welfare Code); Republic Act No. 7610 of 1992 (Special Protection of Children Against Child Abuse, Exploitation, and Discrimination Act) otherwise known as the “Children Protection Law”; and Sections 17 (b) (2) (iii) (iv) (5) and (xiv) of R. A. No. 7160;

WHEREAS, the subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 511 (a) of R.A. No. 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Noel C. Bince and Salvador S. Perez, Jr. and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—


