PROVINCIAL RESOLUTION NO. 796-2023

AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) BETWEEN THE PHILIPPINE SOCIETY FOR CERVICAL PATHOLOGY AND COLPOSCOPY, INC. (PSCPC) AND THE PANGASINAN PROVINCIAL HOSPITAL FOR THE CONDUCT OF FREE CERVICAL CANCER LECTURES AND SINGLE VISIT APPROACH FOR CERVICAL CANCER SCREENING

WHEREAS, the Philippine Society for Cervical Pathology and Colposcopy (PSCPC) is a non-government organization whose primary objective is to improve health care in the detection and management of lower genital tract disease;

WHEREAS, the PSCPC has been continually conducting medical education, standardization of terminology and evaluation of diagnostic and therapeutic procedures, promoting research and maintaining good standing as a member of the International Federation of Cervical Pathology and Colposcopy;

WHEREAS, the Provincial Government of Pangasinan, through the Pangasinan Provincial Hospital, in partnership with the PSCPC will join efforts in conducting a free cervical cancer screening and lay forum on September 14, 2023;

WHEREAS, cervical cancer screening using Visual Inspection with Acetic Acid (VIA) and colposcopy to those with positive VIA shall be the services to be offered to preferably residents of the Province of Pangasinan during the said 1-day activity medical mission;

WHEREAS, it is to the best interest of the Provincial Government of Pangasinan to authorize the Provincial Governor to sign a Memorandum of Agreement to further augment the need for medical services of the Province for the said program;

NOW THEREFORE, on motion of SP Members Shiela Marie F. Baniqued, duly seconded, it was -


