## PROVINCIAL RESOLUTION NO. 797-2023

DIRECTING THE COMMITTEES ON BARANGAY AND RURAL DEVELOPMENT, PUBLIC ORDER AND SAFETY; ENVIRONMENT, NATURAL RESOURCES AND ENERGY; AND HEALTH TO CONDUCT AN INQUIRY, IN AID OF LEGISLATION, TO LOOK INTO THE CAUSE OF THE EXPLOSION INCIDENT THAT HAPPENED IN SITIO CALIT, BARANGAY BANAOANG, CALASIAO, PANGASINAN LAST SEPTEMBER 9, 2023

WHEREAS, the Sangguniang Panlalawigan is expressing its deep concern over an explosion incident that happened in Sitio Calit, Barangay Banaoang, Calasiao, Pangasinan that led to the death of one person and wounding of another who is now recovering at the hospital;

WHEREAS, as per initial report, it is alleged that the incident happened while the two were repairing a company vehicle of Great Star Laboratories in a garage using a wielding machine and grinder when the explosion occurred;

WHEREAS, this unfortunate incident cannot be allowed to pass without any action being undertaken by the Provincial Government of Pangasinan through the Sangguniang Panlalawigan;

WHEREAS, the Sangguniang Panlalawigan as the highest legislative body of the Province is empowered to conduct an inquiry/committee hearing on certain matters that are of public interest and in aid of legislation;

WHEREAS, the Committees on Barangay and Rural Development, Public Order and Safety; Environment, Natural Resources and Energy; and Health, are the proper Committees to conduct the committee hearing as the matter of further protecting the safety and well-being of the populace is within their specific areas of legislation to address;

WHEREAS, it is requested that the Committees on Barangay and Rural Development, Public Order and Safety; Environment, Natural Resources and Energy; and Health shall conduct the said committee hearing and set the same the soonest possible time and invite concerned authorities that can apprise the Sangguniang Panlalawigan on the explosion incident;

**WHEREFORE,** on motion of SP Member Shiela Marie F. Baniqued, duly seconded, it was –

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled to direct, as they are hereby directed, the Committees on Barangay and Rural Development, Public Order and Safety; Environment, Natural Resources and Energy; and Health to conduct an inquiry, in aid of legislation, to look into the cause of the explosion incident that happened in Sitio Calit, Barangay Banaoang, Calasiao, Pangasinan last September 9, 2023;

Zaplan, Chairman, Committee on Barangay and Rural Development, Public Order and Safety; SP Member Vici M.
