**APPROVING SB RESOLUTION NO. 61, S-2023 OF THE SANGGUNIANG BAYAN OF BANI, PANGASINAN, ENTITLED "APPROVING THE CONSTRUCTION OF BOX CULVERT PROJECT AMOUNTING TO ONE MILLION ONE HUNDRED TEN THOUSAND (P1,110,000.00) LOCATED IN BARANGAY ARWAS, THIS MUNICIPALITY, FUNDED BY THE MUNICIPAL DEVELOPMENT FUND SAVINGS CY 2017-2022 AND GENERAL FUND CY 2023"**

**WHEREAS**, the Sangguniang Bayan of Bani, Pangasinan submitted its SB Resolution No. 61, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

**WHEREAS**, the proposed Construction of Box Culvert project amounting to PhP1,110,000.00, which will be funded on the same source of fund mentioned in SB Resolution No. 60, S-2023, also emanated from the Local Development Council and was endorsed to the Sangguniang Bayan thru MDC Resolution No. 2023-03 on July 6, 2023. This is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991;

**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Bani, Pangasinan;
