RESOLUTION NO. 803-2023

DECLARING MUNICIPAL ORDINANCE NO. 08, S-2023 OF THE SANGGUNANG BAYAN OF BANI, PANGASINAN, ENTITLED “AN ORDINANCE AMENDING SECTION 3. VI.A. OF MUNICIPAL ORDINANCE NO. 02, S-2021 “CREATING FOURTEEN (14) PLANTILLA POSITIONS IN THE LOCAL GOVERNMENT UNIT OF BANI, PANGASINAN AND ALLOCATING FUNDS THEREOF” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT


