DECLARING MUNICIPAL ORDINANCE NO. 08, S-2023 OF THE SANGGUNIANG BAYAN OF BANI, PANGASINAN, ENTITLED "AN ORDINANCE AMENDING SECTION 3. VI.A. OF MUNICIPAL ORDINANCE NO. 02, S-2021 "CREATING FOURTEEN (14) PLANTILLA POSITIONS IN THE LOCAL GOVERNMENT UNIT OF BANI, PANGASINAN AND ALLOCATING FUNDS THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Bani, Pangasinan submitted its Municipal Ordinance No. 08, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;
