**RESOLUTION NO. 805-2023**

**DECLARING THE SUPPLEMENTAL BUDGET NO. 1 FOR CALENDAR YEAR 2023 OF BOLINAO, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P20,300,000.00, OPERATIVE IN ITS ENTIRETY**

**WHEREAS**, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

**WHEREAS**, the Sangguniang Bayan of Bolinao, Pangasinan submitted its Supplemental Budget No. 1 for Calendar Year 2023 involving total appropriations of P20,300,000.00, which was enacted on June 29, 2023 through Appropriation Ordinance No. 2023-01;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That the funding sources for the subject supplemental budget were determined in accordance to Section 321 of R.A. 7160 and Article 417 (a) of its IRR as amended by Administrative Order No. 47 dated April 12, 1993;

2. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and the FY 2023 Supplemental Investment Program of the municipality formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2007 dated March 8, 2007;
3. That all procurements to be undertaken shall be subject to the pertinent provisions of R.A. 9184 (The Government Procurement Reform Act) and its Implementing Rules and Regulations; and
4. That the purchase of transportation equipment shall be subject to the provisions of Budget Circular No. 2022-1 dated February 11, 2022 re "Omnibus Guidelines on the Acquisition, Use, Rental & Replacement of Government Motor Vehicles" & Budget Circular No. 2022-1A dated March 1, 2023, (Supplemental Guidelines on the Acquisition, Use, Rental & Replacement of Government Motor Vehicles).


**WHEREAS**, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—


