RESOLUTION NO. 807-2023

DECLARING ORDINANCE NO. 8, S-2023 OF THE SANGGUNIANG BAYAN OF CALASIAO, PANGASINAN, ENTITLED “AN ORDINANCE ENACTING THE EXPANDED CHILD WELFARE CODE OF THE MUNICIPALITY OF CALASIAO, PANGASINAN 2023-2028” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT

WHEREAS, the Sangguniang Bayan of Calasiao, Pangasinan submitted its Ordinance No. 08, Series of 2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to The United Nations Convention on the Rights of the Child; Presidential Decree No. 603 or “The Child and Youth Welfare Code; Republic Act No. 7610 known as “Special Protection of Children Against Child Abuse , Exploitation, and Discrimination Act”; and Section 17 (b) (2) (iii) (iv) (5) (xiv) of R.A. No. 7160;

WHEREAS, the subject ordinance shall take effect after compliance with the requirements of posting and publication pursuant to Sections 59 and 511 (a) of R.A. No. 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Shiela Marie F. Baniqued and Vici M. Ventanilla and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—




