## **RESOLUTION NO. 814-2023**

DECLARING ORDINANCE NO. 23-15 OF THE SANGGUNIANG PANLUNGSOD OF SAN CARLOS, PANGASINAN, ENTITLED "THE GUIDELINES ON PRE-EMPTIVE AND FORCED EVACUATION IN TIMES OF DISASTER OR CALAMITY IN THE CITY GOVERNMENT OF SAN CARLOS, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Panlungsod of San Carlos, Pangasinan submitted its Ordinance No. 23-15 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Republic Act No. 10121, otherwise known as the "Philippine Disaster Risk Reduction and Management Act of 2010"; Department of the Interior and Local Government Memorandum Circular No. 2012-35; DSWD-DILG-DOH-DepED Joint Memorandum Circular No. 1, Series of 2013, entitled "Guidelines on Evacuation Center Coordination and Management" and Sections 16, 455 (b) (viii) and 458 (a) (1) (iv) of R.A. No. 7160;

WHEREAS, the subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 511 (a) of R.A. No. 7160;
