### RESOLUTION NO. 820-2023

#### APPROVING RESOLUTION NO. 201-2023 OF THE SANGGUNIANG BAYAN OF URBIZTONDO, PANGASINAN, ENTITLED "APPROVING THE AMENDED SUPPLEMENTAL INVESTMENT PROGRAM NO. 2 FOR CALENDAR YEAR 2023 OF THE MUNICIPALITY OF URBIZTONDO, PANGASINAN"

**WHEREAS**, the Sangguniang Bayan of Urbiztondo, Pangasinan submitted its SB Resolution No. 201-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. The Municipal Development Council of Urbiztondo, Pangasinan prepared the amended Supplemental Investment Program (SIP) No. 2 for CY 2023. This was endorsed by the Council, through MDC Resolution No. 04, S-2023 dated July 27, 2023, to the Sangguniang Bayan for approval;
2. The amended Supplemental Investment Program, which has a total investment requirement of ₱211,368,325.00, covers various priority development projects of the municipality to be funded from the loan proceeds of the LGU from the Land Bank of the Philippines;

3. Based on the MDC Resolution, the previously approved SIP No. 2, CY 2023 was amended as the total investment cost exceeded the borrowing capacity of the LGU from P 243,350,125.00 to P 211,368,325.00. Thus, the following projects are removed/excluded from the previously approved SIP No. 2, CY 2023 of the LGU to meet the borrowing capacity of the LGU, which amounts to P211,368,325.00, to wit:

4. Concreting of Farm-to-Market Road at Brgy. Bayaoas	P 13,981,800.00
5. Purchase of one (1) unit Wheel Loader	P 3,100,000.00
6. Purchase of one (1) unit Excavator	P 3,700,000.00
