RESOLUTION NO. 822-2023

DECLARING ORDINANCE NO. 9-2023 OF THE SANGGUNIANG BAYAN OF URBIZTONDO, PANGASINAN, ENTITLED "AN ORDINANCE APPROVING AND RATIFYING THE TERMS AND CONDITIONS OF THE APPROVED LOAN AND OTHER SUPPORTING DOCUMENTS PERTAINING TO THE LOAN ENTERED INTO BY AND BETWEEN THE MUNICIPAL OF URBIZTONDO, PANGASINAN, GOVERNMENT REPRESENTED BY ITS MUNICIPAL MAYOR, HON. MODESTO M. OPERANIA, AND THE LAND BANK OF THE PHILIPPINES, REPRESENTED BY ITS ASSISTANT VICE PRESIDENT/HEAD, PANGASINAN LENDING CENTER, MR. CESAR N. ULPINDO, IN THE AMOUNT NOT EXCEEDING TWO HUNDRED ELEVEN MILLION THREE HUNDRED SIXTY EIGHT THOUSAND THREE HUNDRED TWENTY FIVE PESOS ONLY (P211,368,325.00) TO FUND THE PROGRAMS AND PROJECTS OF THE MUNICIPALITY INCLUDED IN THE APPROVED AMENDED SUPPLEMENTAL INVESTMENT PROGRAM NO. 2 FOR CY 2023" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Urbiztondo, Pangasinan submitted its Ordinance No. 9-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and Provincial Plaaning and Development Coordinator have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 22 (a) (5) (c), 296 (a) (b), 297 (a) (b), 444 (1) (vi) & 447 (a) (2) (iii) (iv) of R. A. No. 7160;

WHEREAS, the aforementioned projects to be funded from the proceeds of loan of the LGU are included in the Amended Supplemental Program No. 2, CY 2023 of the Municipality of Urbiztondo, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Philip Theodore E. Cruz and Haidee S. Pacheco and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 9-2023 of the Sangguniang Bayan of Urbiztondo, Pangasinan, entitled "An Ordinance approving and ratifying the terms and conditions of the approved loan and other supporting documents pertaining to the loan entered into by and between the Municipal Government of Urbiztondo, Pangasinan, represented by its Municipal Mayor, Hon. Modesto M. Operania, and the Land Bank of the Philippines, represented by its Assistant Vice President/Head, Pangasinan Lending Center, Mr. Cesar N. Ulpindo, in the amount not exceeding Two Hundred Eleven Million Three Hundred Sixty Eight Thousand Three Hundred Twenty Five Pesos Only (P211,368,325.00) to fund the programs and projects of the Municipality included in the approved amended Supplemental Investment Program No. 2 for CY 2023" as within the conferred powers of the Sangguniang Bayan to enact;
