PROVINCIAL RESOLUTION NO. 828-2023

AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH THE MUNICIPALITY OF ROSALES, PANGASINAN, REPRESENTED BY MAYOR WILLIAM S. CEZAR, FOR THE DESIGNATION/TEMPORARY ASSIGNMENT OF ENGR. JONATHAN B. RAMOS, ASSISTANT PROVINCIAL ENGINEER, AS IN-CHARGE OF OFFICE OF THE MUNICIPAL ENGINEERING OFFICE OF ROSALES, PANGASINAN

WHEREAS, Municipal Mayor William S. Cezar of Rosales, Pangasinan, in his letter dated September 7, 2023, has requested the Province of Pangasinan, through the Provincial Governor, Ramon V. Guico III, to authorize and approve Engr. Amadeo B. Veras, Provincial Engineer of the Provincial Government of Pangasinan as the official signatory of the Local Government Unit of Rosales, Pangasinan;

WHEREAS, the above request was brought about by the mandatory retirement of Engineer Osmundo Fernandez, Officer in Charge of the Municipal Engineering Office of Rosales, Pangasinan last July 30, 2023;

WHEREAS, the Provincial Legal Office, in its opinion dated September 15, 2023, finds no legal impediment to the requested designation or detail of a Provincial Engineer to the Municipality of Rosales considering that it is in accordance with Section 12 (3) (14), Chapter 3, Title I (A), Book V of the Administrative Code of 1987; and Section 13 (b) 2017 Omnibus Rules on Appointments and other Human Resource Actions (Revised July 2018);

WHEREAS, the Provincial Legal Office has further opined that a Memorandum of Agreement specifying the arrangements between the local chief executives is one of the requirements to effect the said requested detail of the Provincial Engineer;

WHEREAS, the Provincial Governor, Ramon V. Guico III, interposes no objection to the said request considering that an engineer is an important and mandatory position in both the provincial and municipal governments, however, he is designating Engr. Jonathan B. Ramos, Assistant Provincial Engineer, as the official signatory and In-Charge of Office of the Municipal Engineering Office of Rosales, Pangasinan;

WHEREAS, Section 22 (c) of RA 7160 stipulated that “Unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the Sanggunian concerned”;

WHEREAS, Section 465 (vi) of RA 7160 further provides that the Provincial Governor shall represent the Province in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon authority of the Sangguniang Panlalawigan or pursuant to law or ordinance;

WHEREAS, for the above purpose, a Memorandum of Agreement shall be entered into and signed between the Province of Pangasinan, represented by the Provincial Governor, Ramon V. Guico III and the Municipality of Rosales, represented by the Municipal Mayor, William S. Cezar;

NOW THEREFORE, on motion of SP Members Arthur C. Celeste, Jr., Noel C. Bince and Salvador S. Perez, Jr., duly seconded, it was -


RESOLVED, by the Sangguniang Panlalawigan in session assembled to authorize, as he is hereby authorized, the Provincial Governor, Ramon V. Guico III, to enter into and sign a Memorandum of Agreement with the Municipality of Rosales, Pangasinan, represented by Mayor William S. Cezar, for the designation/temporary assignment of Engr. Jonathan B. Ramos, Assistant Provincial Engineer, as In-Charge of Office of the Municipal Engineering Office of Rosales, Pangasinan;
