DECLARING MUNICIPAL ORDINANCE NO. 1, S-2022 OF THE SANGGUNIANG BAYAN OF MABINI, PANGASINAN, ENTITLED "AN ORDINANCE RETITLING OF THE POSITION OF NURSE II SALARY GRADE SEVENTEEN (SG 17) TO NURSE III SALARY GRADE SEVENTEEN (SG 17) IN THE MUNICIPALITY OF MABINI, PROVINCE OF PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT
