### PROVINCIAL RESOLUTION NO. 830-2023

**AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH THE MUNICIPALITY OF MANAOAG, PANGASINAN, REPRESENTED BY MAYOR JEREMY AGERICO B. ROSARIO FOR THE DESIGNATION/TEMPORARY ASSIGNMENT OF MR. MARK ANTHONY P. DELA PEÑA, LOCAL ASSESSMENT OPERATIONS OFFICER 1, AS THE OIC MUNICIPAL ASSESSMENT OFFICER OF THE MUNICIPAL ASSESSMENT OFFICE OF MANAOAG, PANGASINAN**

**WHEREAS**, Municipal Mayor Jeremy Agerico B. Rosario of Manaoag, Pangasinan, in his letter dated August 22, 2023, has requested the Province of Pangasinan, through the Provincial Governor, Ramon V. Guico III, to approve the schedule of work of Mr. Mark Anthony P. Dela Peña, Local Assessment Operations Officer 1 of the Provincial Government of Pangasinan from Monday to Friday to be designated as OIC Municipal Assessment Officer of the Municipal Assessment Office of Manaoag, Pangasinan;

**WHEREAS**, the Provincial Legal Office, in its opinion dated September 21, 2023, finds the said request to be in accordance with Section 12 (3) (14), Chapter 3, Title I (A), Book V of the Administrative Code of 1987; and Section 13 (b) 2017 Omnibus Rules on Appointments and other Human Resource Actions (Revised July 2018);

**WHEREAS**, the Provincial Legal Office has further opined that a Memorandum of Agreement (MOA) specifying the arrangements between the local chief executives is one of the requirements to effect the said detail of Mr. Dela Peña;

**WHEREAS**, the Provincial Governor, Ramon V. Guico III, is willing to designate Mr. Dela Peña as OIC Municipal Assessment Officer of the Municipal Assessment Office of Manaoag, Pangasinan on a temporary basis;

**WHEREAS**, in one of the provisions of the MOA, Mr. Dela Peña must physically report to the Office of the Municipal Assessor of Manaoag, Pangasinan from Monday to Thursday and to the Provincial Assessor's Office on Friday;

**WHEREAS**, Section 22 (c) of RA 7160 stipulated that "Unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the Sanggunian concerned";

**WHEREAS**, Section 465 (vi) of RA 7160 further provides that the Provincial Governor shall represent the Province in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon authority of the Sangguniang Panlalawigan or pursuant to law or ordinance;

**WHEREAS**, for the above purpose, a Memorandum of Agreement shall be entered into and signed between the Province of Pangasinan, represented by the Provincial Governor, Ramon V. Guico III and the Municipality of Manaoag, represented by Mayor Jeremy Agerico B. Rosario;

**NOW THEREFORE**, on motion of SP Member Jerry Agerico B. Rosario, duly seconded, it was -


**RESOLVED**, by the Sangguniang Panlalawigan in session assembled to authorize, as he is hereby authorized, the Provincial Governor, Ramon V. Guico III, to enter into and sign a Memorandum of Agreement with the Municipality of Manaoag, Pangasinan, represented by Mayor Jeremy Agerico B. Rosario for the designation/temporary assignment of Mr. Mark Anthony P. Dela Peña, Local Assessment Operations Officer 1, as the OIC Municipal Assessment Officer of the Municipal Assessment Office of Manaoag, Pangasinan;
