PROVINCIAL RESOLUTION NO. 834-2023

REITERATING THE STAND OF THE SANGGUNIANG PANLALAWIGAN THAT FOR ANY VIOLATION OF PERTINENT GOVERNMENT OFFICIALS AND PRIVATE INDIVIDUALS WITH REQUIREMENTS OF LAW APPURTENANT TO THE IMPLEMENTATION OF A PROPOSED PROJECT IN THE PROVINCE SHALL RESULT IN THE FILING OF APPROPRIATE AND NECESSARY ACTION AGAINST THEM IN PROPER COURTS OR OTHER JURISDICTIONS

WHEREAS, the Sangguniang Panlalawigan as the legislative body the Province is empowered to enact measures that would redound to the benefit of the people of Pangasinan in pursuance to the provision of the general welfare clause of RA 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Provincial Government of Pangasinan, in pursuance to Section 16 of the Local Government Code, shall adopt measures to promote and protect within its respective territorial jurisdictions, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants;

WHEREAS, it has been the policy of the Province to promote at the same time, regulate any project, undertaking or activity not only by private individuals and/or entity/ies within its territorial jurisdiction but also by government agencies and offices;

WHEREAS, it is the stand of the Sangguniang Panlalawigan that in the implementation of any project in the Province of Pangasinan, it can gain social and economic benefits, and at the same time, can open to others, the proper use of local resources;

WHEREFORE, in view of the foregoing, on motion of SP Member Vici M. Ventanilla, duly seconded, it was –


