DÉCLARING MUNICIPAL ORDINANCE NO. 01, S-2023 OF THE SANGGUNIANG BAYAN OF DASOL, PANGASINAN, ENTITLED "AN ORDINANCE INSTITUTIONALIZING ASIN FESTIVAL EVERY 3RD WEDNESDAY TO SATURDAY OF FEBRUARY AND EVERY YEAR THEREAFTER AND APPROPRIATING FUNDS THEREFOR IN THE MUNICIPALITY OF DASOL, PANGASINAN, AMENDING FOR THE PURPOSE SECTIONS I, II, III, IV MUNICIPAL ORDINANCE NO. 02, S-2017, ENTITLED "AN ORDINANCE DECLARING "FIRST SATURDAY OF LENT" AND EVERY YEAR THEREAFTER AS "ASIN FESTIVAL" IN THE DASOL, PANGASINAN AND MUNICIPALITY OF FUNDS THEREOF" THE APPROPRIATING AS WITHIN **CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**

A. No. 7160;
