## **RESOLUTION NO. 844-2023**

DECLARING MUNICIPAL ORDINANCE NO. 04, S-2023 OF THE SANGGUNIANG BAYAN OF DASOL, PANGASINAN, ENTITLED "AN ORDINANCE GRANTING MR. CELSO ESPINOZA BALLARES A FRANCHISE TO OPERATE COCKPIT IN BARANGAY AMALBALAN, DASOL, PANGASINAN, SUBJECT TO EXISTING LAWS, RULES AND REGULATIONS" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

**WHEREAS**, the Sangguniang Bayan of Dasol, Pangasinan submitted its Ordinance No. 04, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;
