DECLARING ORDINANCE NO. 03, S-2023 OF THE SANGGUNIANG BAYAN OF INFANTA, PANGASINAN, ENTITLED "AN ORDINANCE CREATING THE PLANTILLA POSITIONS OF SUPERVISING ENVIRONMENTAL MANAGEMENT SPECIALIST UNDER THE OFFICE OF THE MUNICIPAL MAYOR AND ADMINISTRATIVE ASSISTANT IV (BOOKBINDER IV) UNDER THE OPERATION OF MARKET AND SLAUGHTERHOUSE OF THE LOCAL GOVERNMENT OF INFANTA, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT
