## RESOLUTION NO. 851-2023

**DECLARING ORDINANCE NO. 013, S-2023 OF THE SANGGUNIANG BAYAN OF LINGAYEN, PANGASINAN, ENTITLED “AN ORDINANCE CREATING THE LITERACY COORDINATING COUNCIL OF THE MUNICIPALITY OF LINGAYEN, PANGASINAN, DEFINING ITS DUTIES AND RESPONSIBILITIES AND FOR OTHER PURPOSES” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Lingayen, Pangasinan submitted its Ordinance No. 013, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Section 17 (b) (2) (iv) of R. A. No. 7160; Section 1 Article XIV of the 1987 Philippine Constitution, DILG Memorandum Circular No. 2007-155 and Administrative Order No. 324, S-1997;

**WHEREAS**, the subject ordinance shall take effect after compliance with the requirement of posting pursuant to Section 59 (a) of R.A. No. 7160;
