RESOLUTION NO. 852-2023

APPROVING RESOLUTON NO. 103, S-2023 OF THE SANGGUNANG BAYAN OF MANAOAG, PANGASINAN, ENTITLED "APPROVING THE 1ST SUPPLEMENTAL INVESTMENT PROGRAM FOR CALENDAR YEAR 2023 OF THE MUNICIPALITY OF MANAOAG, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Manaoag, Pangasinan submitted its SB Resolution No. 103, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. The Municipal Development Council of Manaoag, Pangasinan prepared the municipality's 1st Supplemental Investment Program for CY 2023. This was endorsed by the Council, through MDC Resolution No.01, Series of 2023 dated March 22, 2023, to the Sangguniang Bayan for approval. This is in accordance to Sections 106, 109 and 114 of the Local Government Code of 1991;
2. Said Supplemental Investment Program (SIP), which has a total investment requirement of ₱17,567,114.83, covers augmentation funds for Personal Services (PS), Maintenance and Other Operating Expenses (MOOE) and Capital Outlay (CO) of some municipal offices of the LGU, and implementation of projects supportive to tobacco farmers, LDRRM and development projects of the municipality; and

3. Funding for the SIP is embodied in the LGU's Supplemental Budget No. 1, CY 2023, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 01, Series of 2023 dated July 19, 2023.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Manaoag, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Marinor B. De Guzman and Jerry Agerico B. Rosario and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—


