DECLARING MUNICIPAL TAX ORDINANCE NO. 2022-001 OF THE SANGGUNANG BAYAN OF SISON, PANGASINAN, ENTITLED “AN ORDINANCE ENACTING THE REVISED REVENUE CODE OF THE MUNICIPALITY OF SISON, PROVINCE OF PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Sison, Pangasinan submitted its Ordinance No. 2022-001 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Acting Provincial Treasurer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 129, 132, 187, 188, 191 & 447 (a) (2) (ii) of R. A. No. 7160;

WHEREAS, subject tax ordinance shall take effect after the requirement of publication pursuant to Section 188 of RA 7160 is complied with;


