RESOLUTION NO. 855-2023

DECLARING ORDINANCE NO. 2023-01 OF THE SANGGUNIANG BAYAN OF SISON, PANGASINAN, ENTITLED “AN ORDINANCE OFFICIALLY NAMING THE PEOPLE OF SISON, PANGASINAN AS “SISONIANS” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Sison, Pangasinan submitted its Ordinance No. 2023-01 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Section 13 of R. A. No. 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—
