**APPROVING AND ADOPTING AS ITS DECISION EN BANC, THE RECOMMENDATION OF THE COMMITTEE ON GOOD GOVERNMENT AND ACCOUNTABILITY OF PUBLIC OFFICERS, JUSTICE AND HUMAN RIGHTS IN SP ADMINISTRATIVE CASE NO. 04-2023 (APPEAL)**

**WHEREAS**, the Sangguniang Panlalawigan was in receipt of a Memorandum of Appeal filed on March 23, 2023 by Sps. Stephen Naugler, Lara Naugler, Jocelyn Ymasa and Stephine B. Ramos against the Decision of the Sangguniang Bayan of San Fabian, Pangasinan in Administrative Case No. 01-2020 dated 9th February 2022;

**WHEREAS**, the said case was referred to the Committee on Good Government and Accountability of Public Officers, Justice and Human Rights and was docketed as SP Administrative Case No. 04-2023;

**WHEREAS**, after several hearings, both parties have decided to settle their case amicably;

**WHEREAS**, the Committee on Good Government and Accountability of Public Officers, Justice and Human Rights submitted its Decision embodied in Committee Report No. 43-2023 by the Sangguniang Panlalawigan, to wit;


