**APPROVING RESOLUTION NO. 2022-250 OF THE SANGGUNIANG BAYAN OF SUAL, PANGASINAN, ENTITLED: "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 5, CY-2022 OF SUAL, PANGASINAN AMOUNTING TO THIRTEEN MILLION SIX HUNDRED TWENTY-TWO THOUSAND THREE HUNDRED THIRTY-SIX PESOS (P13,622,336.00)"**

**WHEREAS**, the Sangguniang Bayan of Sual, Pangasinan submitted its Resolution No. 2022-250 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Sual, Pangasinan has identified items in their Supplemental Investment Program (SIP) No.5 for CY 2022. This was endorsed to the Sangguniang Bayan for approval on December 5, 2022 by the Municipal Development Council (Executive Committee) thru Resolution No. 3, Series of 2022;

2. The SIP No. 5 of the municipality covers fund augmentation for Personal Services (granting of Performance-Based Bonus, Collective Negotiation Agreement Incentive & Service Recognition Incentive to qualified LGU officials/employees) and Maintenance and Other Operating Expenses of some municipal government offices, and implementation of disaster risk reduction management programs; and
3. Said SIP has a total investment requirement of PhP13,622,336.00 and is supported by their proposed Supplemental Budget No. 6 for Calendar Year 2022 which was enacted by their Sangguniang Bayan thru Appropriation Ordinance No. 07 on December 12, 2022.

**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Sual, Pangasinan;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 2022-250 of the Sangguniang Bayan of Sual, Pangasinan, entitled “Approving the Supplemental Investment Program (SIP) No. 5, CY-2022 of Sual, Pangasinan amounting to Thirteen Million Six Hundred Twenty-Two Thousand Three Hundred Thirty-Six Pesos (P13,622,336.00)”;
